Kirtland Community College is offering artists an opportunity to be creative, work outside the box, have fun, and make a little money. Viewing of the exhibition begins Friday, August 6, at 4 pm with an invitation reception for artists and community members. All art work must stay on display through Sunday, August 8, 2010. Sale of artwork will be conducted between the artist and the buyer after 4 pm on Sunday, August 8, 2010. A \$100 award will be presented to the popular vote winner.

### **APPLICATION ELIGIBILITY/GUIDELINES**

- ❖ Open to all members of the *Kirtland Art Guild*. (Membership fee \$20—if paid before July 17, 2010; \$30 after.)
- ❖ Work delivered will be juried for final acceptance.
- ❖ **Three** pieces of fine art will be accepted from the following categories: wood, wood carvings or burnings, two dimensional media and mixed media, jewelry, fiber to include wood or fabric, pottery, metal, and glass or glass fusing.
- ❖ **Ten** 5x7x1 inch two dimensional art work in any media or mixed media will be accepted. Art work must fit in a 5x7 inch clear jacket that will be pinned to a display or wall. Art in other mediums will also be accepted but must fit in a 5x7 inch jacket. Since space is limited, no more than five pieces from one individual will be hung at a time. All small works are for sale at \$50 or less. A 30% commission will be taken on small works only.
- ❖ **ONLY ORIGINAL WORKS OF ART WILL BE ACCEPTED**, no prints please. Not for sale (NFS) entries will NOT be accepted. Kirtland Community College Business Office will forward proceeds from sales to the undersigned within 14 days of the closing of the Celebration of Fine Art! less a 30% processing/administration fee.
- ❖ Work must be framed and with wire (no saw tooth hooks) ready for hanging.
- ❖ Jewelry must be presented in display trays.
- ❖ Work must be labeled with the provided labels.

### **GENERAL ENTRY INFORMATION**

- ❖ **DEADLINE TO RECEIVE ALL ENTRIES IS JULY 17, 2010.**
- ❖ Entry fee/guild membership fee is \$20. (After July 17, 2010 the membership fee is \$30.)
- ❖ Artwork must be hand delivered on **Wednesday, August 4, 2010** at the Roscommon County Annex in Roscommon between the hours of 8 am-noon and 5 pm-7 pm. Small works must be mailed and post marked no later than **Friday, July 29, 2010** to C and J Storage, PO Box 1057, Prudenville MI 48651. Self-addressed stamped envelope must be provided for return.
- ❖ Unsold items will be available for pick up at the Roscommon County Annex in Roscommon after 3 pm on Sunday, August 8, 2010. Please be prepared to provide identification as you remove art. Any work remaining beyond that date becomes the property of Kirtland Community College.
- ❖ All participating artists must have a W-9 form on file. Forms will be available by calling 989-275-5000 ext. 388; by email [taylorl@kirtland.edu](mailto:taylorl@kirtland.edu) or on the college website at [www.kirtland.edu](http://www.kirtland.edu).
