- I. ROUTINE
  - Chairperson Mary Ann Ferrigan called the meeting to order at 6:30 p.m. in Kirtland's President's Conference room.
  - Roll Call Five Board members were present.

## **II. SPECIAL BUSINESS**

- The Special meeting was called to discuss the college's counteroffer to the buyer's first amendment to the Purchase Agreement for the Roscommon Property.
- Motion by Roy Spangler to Approve the buyer's counteroffer to the first amendment to the Purchase Agreement. Seconded by Tom Ritter. Discussion ensued regarding insurance on the property: title insurance, land contract deadline, property taxes, hazard insurance on the property, buyer's credit report, payment plan, and changes made to the Land contract. Motion died on the floor.
- Changes to the Land Contract discussed hazard insurance to be maintained on the property and Kirtland's name added as loss payee; duplicate sentences in the contract to be removed.
- Chairperson MaryAnn Ferrigan requested a vote from members present to Approve the Buyer's counter offer to Kirtland's First Amendment to the Purchase Agreement – Roll Call Vote = Tom Ritter – Nay, Ed Pearen – Nay, Alan Bruder – Nay, MaryAnn Ferrigan – Nay. 0/4 No Approval.
- Chairperson MaryAnn Ferrigan requested a vote from members present to approve the second proposal to the first amendment to the Purchase Agreement on the Roscommon property with these amendments:
  - All accumulated interest will be paid as of the date of the payment (June 1, 2024)
  - Hazard insurance will be purchased on the property, and Kirtland will be named on the policy.
  - Request of a Credit Report be provided on both of the Buyers
  - o Update/recent Financial Statements of both Buyers (D. Armistead and D. Hartman)

Roll call vote – Alan B. – Aye, Tom Ritter – Aye, Roy Spangler – Aye, Ed Pearen – Aye, MaryAnn Ferrigan – Aye. 5/0 – approval of amendments to be contained in a second proposal to a first amendment to the Purchase Agreement for the Roscommon property

• Trustees Bruder, Ritter, Pearen, and Spangler expressed they did not want the deal to fall apart because of the buyer's refusal to provide a credit report and gave Quinn the option to negotiate that issue.
