Discussion with administration regarding updated wording in policy as the last policy was revised in 1993. <u>Motion:</u> by trustee, Amy Knepp accepts revision in policy and moves to a second reading. <u>Second:</u> by trustee Tom Ritter. No further discussion. Motion carries, passed without descent.
- Repeal to POL 5.200 Classified Temporary Employees Administration request policy be repealed as it is a duplication of policy 5.345 Definition and Description of Employee Categories and because the Department of Labor definitions have changed in 1988. <u>Motion</u> by trustee Ed Pearen to repeal POL 5.200. <u>Second</u>, by trustee Jack Kramer. No further discussion. Motion carries, passes without descent.
- Revisions to POL 5.305 Review and Maintenance of Classification Compensation Structures. Administration recommends minor changes in wording to bring policy current. No further discussion. <u>Motion:</u> by trustee Jack Kramer to accept revisions and move policy to a second reading Seconded: by trustee Ed Pearen. No further discussion. Motion carries, passes without descent.
- Repeal of POL 5.320 Temporary Reclassification. Discussion of administration's recommendation for guidance on policy. Dialogue with board members, Human Resources, and administration regarding use of the policy; legal aspects of policy, and current procedures. <u>Motion</u> by trustee Ed Pearen to repeal policy. <u>Second</u>, by trustee Jack Kramer. No further discussion. Motion carries. Passed unanimously without descent.
- Revisions to POL 5.325 Hiring Rates. Discussion on administration's recommendation of minor policy revisions. Dialogue with members of administration regarding minor changes in policy wording. <u>Motion:</u>

by trustee Kramer to accept amendments and move POL 5.325 to a second reading. <u>Seconded</u> by trustee Ritter. No further discussion. Motion carries. Passed unanimously without descent.

second read. <u>Seconded</u> by trustee Kramer. No further discussion. Passed unanimously without
descent.
