Articulation Agreement Grand Valley State University College of Health Professions Physician Assistant Program And Kirtland Community College

Grand Valley State University College of Health Professions ("GVSU") and Kirtland Community College agree to establish an Articulation Agreement ("Agreement") in which one qualified Kirtland Community College student shall be granted an interview with the GVSU Physician Assistant Program ("Program") Traverse City Campus annually. This agreement shall be effective upon final signatures by the administrators and institutional representatives at both GVSU and Kirtland Community College.

One qualified Kirtland Community College student who meets all Program admission criteria listed below and on the Program website and those who have ties to northern Michigan through community college credits will be granted an interview for the Program.

Program Eligibility:

To be eligible for interview consideration to the Program, Kirtland Community College students shall have the following:

- 1. Met all Program admission criteria.
- Completed an application through the Centralized Application Service for Physician Assistants (CASPA)
 prior to the application deadline, as noted on the Program website. Applications must include a) the
 GVSU supplemental form, b) a minimum of two CASPA recommendation rubrics, c) the GVSU \$30
 application fee, and d) all official college transcripts.
- 3. Have earned a minimum overall grade point average, Program pre-requisite grade point average, and last 60 credit hour grade point average of 3.5. See the Program <u>website</u> for further details regarding calculation of grade point averages. No grade below a "C" is acceptable for pre-requisite coursework.
- 4. Have earned a minimum of 30 undergraduate credits at Kirtland Community College.
- Completed a minimum of 1000 hours of significant volunteer and/or work and/or observational hours in a health care environment. Hands-on patient care activities are strongly encouraged. This information will be documented on the CASPA application. Refer to Program website for additional details.
- 6. International students must submit an official TOEFL (Test of English as a Foreign Language), IELTS (International English Language Testing System), DuoLingo, or PTE Academic (Pearson Test of English Academic) score report if English is not the student's first language. The minimum TOEFL score is 80 (Note: GVSU does not accept "My Best" score for admission), the minimum IELTS score is 6.5, the minimum DuoLingo score is 105, and the minimum PTE Academic score is 53. Original score reports must be submitted.

Institutional Requirements:

GVSU agrees to:

1. Provide Kirtland Community College documentation of pre-requisite coursework via the Program website.

- Make reasonable efforts to assist Kirtland Community College in attracting and retaining students in sufficient numbers to meet the terms of this Agreement; at the direction of Kirtland Community College, this may include GVSU participation in Kirtland Community College -sponsored events for new student recruitment and orientation programming.
- Serve as a resource for Kirtland Community College faculty, advisors and students to provide career counseling and advising regarding the Physician Assistant profession and GVSU's Physician Assistant Program.
- 4. Conduct periodic campus visits and/or co-host receptions at Kirtland Community College as requested.
- 5. Review application materials for all Kirtland Community College students who have met all the Program admission requirements.
- 6. Offer a Program interview to one (1) Kirtland Community College student who meet eligibility criteria.
- 7. Provide opportunities through campus visits or other acceptable methods to interested students, faculty, and staff to learn more about the Program.
- 8. Market the Program to potential pre-Physician Assistant students with Kirtland Community College.
- 9. Provide timely notice to Kirtland Community College of any Program changes that may impact this Agreement, including, but not limited to, change in the Program's ARC-PA accreditation status, change in the affiliation and/or accreditation status of GVSU with the North Central Association of Colleges and Schools/Commission on Institutions of Higher Education.

Kirtland Community College agrees to:

- Make every effort to regularly offer all prerequisite courses for the program as identified by GVSU.
 However, if enrollment does not meet the necessary levels, they reserve the right to adjust offerings.
 Students enrolled in these courses will be accommodated and provided reasonable opportunities to register for all required courses to help them meet program requirements.
- 2. Provide advance notice to GVSU of changes to previously identified pre-requisite course(s) to allow review and confirmation that revised courses will continue to meet Program requirements.
- 3. Make reasonable efforts to recruit a sufficient number of students to meet the terms of this Agreement.
- 4. Provide career counseling and advising activities that include information about the Physician Assistant profession in a manner similar to other pre-health profession advising.
- 5. Market the Program to potential pre-Physician Assistant students at Kirtland Community College.
- 6. Provide timely notice to GVSU of any Program changes that may impact this Agreement, including, but not limited to, decline in admission standards, changes in institutional grading practices and standards, changes in graduation requirements, or changes in the affiliation or accreditation status of Kirtland Community College with the Higher Learning Commission.
- 7. If requested by GVSU, assist the Program by providing information regarding this articulation agreement to the Program's accrediting agency, Accreditation Review Commission on Education for the Physician Assistant (ARC-PA).

Admission to the GVSU PAS Program

- 1. Being granted an interview does not guarantee an offer of admission to the Program.
- 2. Kirtland Community College students who are offered admission by GVSU and choose to accept the admission offer to the Program must:
 - a. Meet all pre-matriculation requirements for their year of matriculation.

b. Maintain an overall grade point average of 3.00 or higher after the admissions decision and prior to matriculation.

Agreement <u>Review:</u> Representatives of both institutions will review the Agreement as needed. The Agreement may be suspended or revoked upon written request by either institution with sixty (60) days advance notice to the Dean of the College of Health Professions (GVSU) or the Director of Nursing and Allied Health (Kirtland Community College).
